University of Iowa service-learning students applying for the Xicotepec Project should read this entire document carefully before beginning the online application

Important note: The information in this document pertains to Rotary's rules, requirements, and guidelines for participants in the Xicotepec Project. If you are enrolled at The University of Iowa or other college or institution, there may be additional requirements.

# **Conditions of Participation**

All applicants must read and agree to these Conditions for Participation in The Xicotepec Project (the "Project"). The Project Coordinators reserve the right to impose additional conditions, restrictions or rules at any time prior to or during the execution of the Project whenever they deem necessary.

- 1. I understand and agree that, as a participant in a Rotary program or project, I am subject to the appropriate and legal conduct of the United States and of the country of the program. I understand that I am also subject to the directions of the Project Coordinators concerning my conduct.
- 2. I agree to participate fully in the Project as programmed by the Project Coordinators and agree that any deviation from programmed activities must be approved in writing by a Project Coordinator.
- 3. I agree that the Project Coordinators may terminate my participation in the program if:
  - a. I engage in actions that endanger myself or others, or
  - b. my conduct is considered to be detrimental or incompatible with the best interest of the Project.

I further agree, if expelled from the Project Team, to be responsible for all ordinary and extraordinary expenses incurred in returning to the United States.

- 4. I understand that I am subject to the laws of the host country and agree to abide by those laws. It is further understood that Rotary and its agents may be limited in their ability to provide assistance in the event of arrest and reserve the right to conduct disciplinary proceedings on their own.
- 5. I am aware of the nature and the cost of the program and will guarantee that all financial obligations related to my participation in the Project will be met.
- 6. I understand that individual travel during the Project is not permitted. I will provide the Project Coordinators with details of any travel undertaken before or after the Project. I understand that any such travel is undertaken at my own risk.

- 7. I understand that Rotary District 6000 reserves the right to cancel the Project in the case of insufficient participation or for other reasons deemed appropriate. Rotary District 6000 also reserves the right to make changes to the Project or alterations in the Project's proposed schedule and itinerary. I further understand that should the Project, or any portion of the Project, be canceled, Rotary District 6000 shall have no responsibility beyond the refund of all deposits made and monies paid to Rotary District 6000 by participants. Minor alterations in the Project's programs are not grounds for refunds.
- 8. I understand that by participating in the Project I am agreeing to learn about the host culture and adapt to it to the best of my ability and not to judge new or unfamiliar ideas and practices by the standards or criteria of my own culture. I am aware that it is both inappropriate and culturally insensitive to use Project time to promote religious or political agendas and that such behavior can cause offense and potentially place me or other members of the Project Team in harm's way. I understand that I should not expect to change the culture I am visiting and that as a member of the Project Team that I should not engage in such activities. I understand that while the USA respects certain rights such as the right of freedom of expression that these are not universal rights and may not be protected by law in some countries. I will conduct myself with respect for the host culture even though I may not agree with every practice or custom of that culture, and I understand that behavior that is inconsistent with this statement may lead to my removal from the Project.
- 9. I understand that in order to participate in this program, that I must be vaccinated for Covid-19 as recommended by the CDC and that I will be subject to CDC rules and those of the Mexican government regarding masking, social distancing, etc.
- 10. I have read the U.S. State Department travel conditions/warnings for Mexico in preparation for this trip (see https://travel.state.gov/content/passports/en/country/mexico.html). I have read and understand the conditions governing my participation in The Xicotepec Project, and I understand the possible actions that may be taken should I act in a manner that is inconsistent with these conditions.

In order to be considered, an applicant must check the box on the online application form that indicates that s/he has read and agrees to and accepts the foregoing Conditions of Participation.

# **Basic Information for all prospective team members:**

### Trip Dates - March 9 - 17, 2024

The Xicotepec Project is a humanitarian, community-development project sponsored by the Rotary Club of Xicotepec and Rotary District 6000 of Iowa. The project began in 2002 and has involved not only Rotarians and their families, but also many high-school and university students. Project team members should have a commitment to humanitarian service and should be prepared to participate enthusiastically throughout their week in Xicotepec.

The main purpose of the March 2024 trip to Xicotepec is to work on selected community projects sponsored by the Xicotepec Rotary Club. You may be asked to perform several different jobs during the week. You may or may not be assigned to the job(s) of your choice, but you are expected to perform the assignments that are given to you. University of Iowa service-learning students enrolled in the International Perspectives course will divide their time between service activities and related academic endeavors according to a pre-established plan.

Other purposes of the trip include experiencing, enjoying and learning about a culture different from your own, promoting fellowship and friendship among people with different cultural, economic, educational, racial and religious backgrounds, and learning more about Rotary in an international context. University of Iowa service-learning participants will also have specific academic goals which they will have developed together with faculty members and each other.

## **Before Applying**

Participation in The Xicotepec Project as a Project Team member is open to service-learning students enrolled in the University of Iowa's "International Perspectives: Xicotepec" service-learning course. Students must be interviewed by and receive permission from course faculty before enrolling.

Before completing the online application form, prospective applicants may want to prepare a *Statement* of *Purpose* and a *Brief Bio*, both of which must be 75 words or less and provided as part of the application. The questions from the application are:

**Statement of Purpose:** Please provide a brief statement of why you wish to participate in The Xicotepec Project. What hopes, expectations or goals do you have and how will your participation in the Project help to fulfill them? In what way do you think you can contribute to the Project?

**Brief Bio:** This will be your first introduction to many of the other team members and to those in Xicotepec – what would you like them to know about you? This brief bio will be used in a Project Team Directory that will be distributed to the rest of the project team and to our Rotarian hosts in Xicotepec. **Note: You may not ask that we use prior years' entries. Please write a new one.** 

# **Applying for the Project Team**

Application forms are filled out online by visiting https://xicoproject.org and clicking on Apply. Service-learning students must have been interviewed by and received permission from course faculty to enroll in the "International Perspectives: Xicotepec" course before applying.

The deadline for submitting applications is midnight, November 12, 2023.

Applicants will receive notice of their acceptance via email by early December, 2023.

## Communication prior to the trip

E-mail will be the primary means of communicating with applicants and project team members. Applicants and participants must have an e-mail account that is checked regularly and that will not fill up or be unavailable. Xicotepec Project news and announcements of general interest are widely distributed by e-mail; non-applicants or non-participants who would like to be on the distribution list may send an e-mail with their request to info@xicoproject.org.

#### **Travel and Costs**

It is your responsibility to have the appropriate passport and arrange for all other travel documentation you may need for air entry to and from Mexico.

- US Citizens
  - A US passport book that does not expire within 6 months of the March 17, 2024 return date is required for this trip.
  - You must have a valid passport by no later than December 31, 2023.
  - A "passport card" is not acceptable for air entry into Mexico and is not accepted for this trip.
  - Upon arrival in Mexico City, the group will go through the standard immigration arrival process.

#### Non US Citizens

- You are responsible for obtaining all the required travel documents according to your citizenship and situation. This may include obtaining a VISA prior to travel or other requirements.
- You must have a valid passport and all other documents required for your travel by no later than December 31, 2023.

Flight itineraries may vary from one person to the next due to seat availability; there is no assurance that you will travel with a particular person, nor at a certain time, nor with regard to the number of connections or the airline(s) you will fly on.

The arrival destination is the Mexico City Benito Juárez International Airport. You will be met at the airport by one or more of the Project Coordinators. Depending on the hour of your arrival, you will either overnight at a hotel in Mexico City or go directly to Xicotepec from the airport by charter bus.

The Xicotepec Project will arrange all essential ground transportation in Mexico on your behalf. All food and lodging while in Xicotepec will be provided. Lodging while in Mexico City will be provided; you will pay for your meals while in Mexico City and on travel days.

You must travel with the rest of the project team unless you have made alternate arrangements which have been approved by the Project Coordinators prior to the beginning of your trip. While in Xicotepec you must participate in the scheduled work or other activities as directed by the Project Coordinators or other leaders; you may not travel or sight-see on your own during the week you are in Mexico with the project team.

Trip costs are based on the actual costs for airfare, lodging, meals, etc. and may change from year to year. The cost for the 2024 trip for service-learning participants is \$2050, plus additional fees required by the University of Iowa International Programs. These charges include double occupancy in a Mexico City hotel.

If you withdraw after being accepted, you will be responsible for payment of all direct and indirect costs resulting from canceled tickets, reservations, etc.

Should cancellation be the result of an unavoidable circumstance (health issue, family emergency, etc.), every attempt will be made to minimize your cost; this depends on the timing of cancellation vs. deadlines for payments to airlines and hotels for tickets and reservations.

# **Safety and Health**

Safety and health of the project team are two prime concerns of everyone involved in the Xicotepec Project; you will not be asked to do anything that is unduly risky or to tolerate unhealthy conditions, and you may refuse to do anything that you believe is unsafe or that might damage your health or the health of others. However, participants should acknowledge that there are inherent risks in traveling to and staying in a developing country and that environmental and sanitary conditions often do not meet customary standards found in the United States.

You must be in reasonably good health in order to participate. In particular, you should be able to walk up to a mile at a time and up to three miles per day and to negotiate uneven terrain on your own. You should be able to perform steady, moderate work under a variety of weather conditions ranging from very hot and humid to cold and damp. You must have health insurance that provides coverage while you are in Mexico; all University of Iowa students will be required to purchase supplemental health care insurance via the University's office of International Programs.

### **Immunizations**

In order to participate in the March 2024 Xicotepec Project team trip, you must be vaccinated for Covid-19. Applicants are also urged to obtain booster shots according to CDC recommendations. You will be required to provide a copy of your vaccination card or other document showing the date(s) of your vaccination. If there are any rules in force in Mexico at the time of your visit regarding masking, social distancing, etc., you must observe them.

If your other standard immunizations are up-to-date, nothing else is required for travel to Mexico. If you are concerned about illnesses which are uncommon in the U.S. such as cholera, malaria, etc. you should contact your family doctor or a travel health clinic for advice.
